Security Report: SACNW Lead Patrol Officer Mr Coy presented the Security Report:

During the month of October to November:

27 people were stopped, searched, and escorted out of area 2 dog problems
Helped 3 groups with golf cart problems
One with Gas

Friday October 14th, **2022, 3:15pm –** Patrol was informed of a traffic accident. Arriving traffic officer was at the scene. Police took over the situation. RRR was called and responded.

Wednesday October 26th, 2022, 5:00 am - Patrol along with Police detained one suspicious person walking the beach

Friday November 4th **11:52pm -** Patrol stop a 6-seater golf cart with 1 male and 2 females, one of the females was on the top of the cart. The driver was informed of his wrongdoing and was asked about his intention.

Security comments by Mr Coy

Patrol is monitoring boats during the night as there has been heightened activity of beach walkers now using docks.

<u>Asst. Superintendent Reyes</u> thanked SACNW for the help that they provide in the South area in Ambergris Caye. He confirmed that with winds coming in from a new direction they bring in substances that the beach walkers are looking for. They know that they can be found on land easier, so they now walk the area and are using boats and docks to escape the area quickly.

<u>Superintendent Alejandro Cowo</u> was introduced as the new chief for the area. He stressed how important the monitoring at the control points were in keeping this given area safe. The word is out that we are protecting the area.

Mr Alejandro expressed his gratitude and commended us for keeping the police alert and making known to those that try to infiltrate the area that it is kept safe. He commented that the cleanup from the hurricane and securing areas has almost completed.

Audience Q & A

Q. With the increase in unwanted visitors from the water do the coastguard assist patrol with sea patrol?

A Mr Reyes – confirmed that the Coastguard are a separate entity but although on hand do not have the smaller boats or manpower to be able to assist with daily patrols.

Q. If an accident happens where a tourist is involved can they be held until they have been cleared of blame so that any \$\$ that should be paid by them can be collected?

A. Mr Reyes - Magistrate can hold and charge but it is up to the Magistrate to manage the payment or take them to court. If it is a serious injury, they can be detained but

these details would have to be established before their flight leaves. Contact details are kept if indeed they need to be reached but being able to claim back from them can be difficult when not in country.

Q – Member gave the example of the employee that was injured by the tourist. She ended up with a fractured L2. She also had to go to Guatemala for 2nd opinion and perhaps surgery. A Fundraiser was held and \$6,500 was raised for her travel and medical costs. The tourists denied doing the crime. The tourists left the next day and have not been held accountable.

A. Mr Reyes - The police questioned several persons whom at the time had no proof that the tourist hit the employee while riding her bicycle. The initial report from the doctor showed no real injury at the time. At the time there was nothing to hold the tourists. The report was given in good time but due to the above evidence they were not able to hold accountable.

The Police cannot give names and details of a person, but the identity can be shared through the embassy level

Q – Member brought up how important it is to know our patrol and asked if there was a a way that their identity could be shared

A. It was discussed that an image of the 5 Patrol Officers would be posted in the Patrol station for review of the south neighborhood members should owners want to familiarize themselves.

Mr. Reyes – Welcomed the suggestions and confirmed that our local police want to have a proactive approach we take best practices from around the world to address our island security and how it is managed.

New Business:

Road - Culverts for Road

Town Council made sure BEL replaced the damaged manhole cover by Marins Store. Crock pond road area was filled and wall was rebuilt prior to the Hurricane. Town Council is sourcing better product from the mainland to fix the road.

Member comment - the Roads South are looking better especially after the rain.
